Installation and Registration

Installation

Its simple to install Aerize Explorer, simply run the installer on your personal computer and follow the on screen instructions.

- 1. Connect your BlackBerry device
- 2. Run the Aerize Explorer installer
- 3. Enjoy!

Registration

Aerize Explorer has a fully functional 14 day trial. When the trial period has ended, you may purchase a Serial Code to enable prolonged usage.

- 1. Purchase a Serial Code
- 2. Open the Aerize Explorer Options
- 3. Enter your Serial Code

General Usage

View Removable Media

Explorer can view files on BlackBerry Devices and Removable Media.

- 1. Insert your SD Card
- 2. Press the back button to move to the base folder
- 3. Choose 'Open' on the desired Removable Media Volume

File and Folder Navigation

Explorer can display all of the folders and files on your device and removable media.

- 1. Select the folder to view
- 2. Choose **'Open'** to view the files and folders
- 3. Press the back button to move up one folder

File and Folder Management (Copy and Move)

Explorer uses the concept of Cut, Copy and Paste to move and copy files and folders. If you would like to move a folder and all of its subfolders and files:

- 1. Select the Folder (or File)
- 2. Chose 'Cut' to Move, 'Copy' to Copy
- 3. Chose 'Paste', when you have navigated to the destination

Zip File Decompression

Explorer can copy individual files from Zip files.

- 1. Navigate to the Source Zip file
- 2. Choose 'Copy' on the file or folder to decompress
- 3. Navigate to the destination and select 'Paste'

Folder Compression

Explorer can compress and folders to Zip files

- 1. Navigate to the Source folder
- 2. Choose **'Compress'** on the folder
- 3. Transfer the Zip file to the destination

Folder Decompression

Explorer can decompress folders from Zip files

- 1. Transfer the Source Zip file to the destination
- 2. Choose **'Decompress'** on the Zip file
- 3. Remove the Source Zip file if desired

Common Questions

Q. Can I move files from the SD card to the device?

A. Yes. Simply navigate to the file or folder you want to move and select the Cut option, then navigate to the destination, and select Paste.

Q. How do I copy files from one SD Card to another?

A. Copy the file or folder from the SD card to your device. Now, switch the SD cards. Then move the file to the new SD card.

Q. How do I view files in a ZIP file?

A. Navigate to the Zip file and Open it like a folder.

Q. How can I upgrade my device software?

- A. Follow the steps bellow:
- 1. Backup your device information
- Download and Install the latest OS for your device.
